

# **REMARKABLE POINTS ON THE MARKET**

The market saw the 6<sup>th</sup> gaining week in a row with smaller growing range. In the middle of the week, there were two strong shakes, but the gain in the beginning and end of the week helped the index staying in green. In which, main motivation came from real estate under the lead of VIC with information related to listing Vinfast in America. Banking tended to different strongly but also contributed some remarkable gainers like STB or CTG. While many foreign large-cap codes were sold, the liquidity was still high as the cash flow tended on penny codes. On the other hand, foreign investors saw a negative week as they turned to a net selling again, ending the chain of 3 net buying weeks previously.

# **TECHNICAL POINT OF VIEW**

VN-Index saw the 6<sup>th</sup> gaining week in a row. On daily chart, the index surpassed peak and saw another gap, but this gap was quickly filled in three following sessions and RSI differentiated, showing high possibility of seeing short-term peak. However, a positive point is that the selling wasn't strong during dropping sessions, matching our expectation that it might only be short-term correction. At the end of the week, there was a positive long base-withdraw candle, but we think that it is only a technical recovery after three drops and the index might drop further during the week after testing peak level. The drop and volume are expected to lower to maintain positive sign. Close support is 1,190-1,200.

## **VN-Index**



HNX-Index saw the 5<sup>th</sup> gain in a row. On daily chart, it has surpassed resistant level of 235-243. The sign hasn't seen clear weakening sign so the index might still continue on middle-term gaining trend toward 260-270. At the end of the week, the index saw a long base-withdraw candle but hasn't surpassed MA5, if it still stays below this line, it might see short-term correction to support level of 235-238 before returning to main gaining trend.



# **HNX-Index**

In general, both indexes might be on short-term correction. However, the market might still differentiate so general strategy might be keeping the weight at average level, considering restructuring portfolio to real estate, retail, public investment, banking, and individual codes with business growth comparing to same period or Q1.


