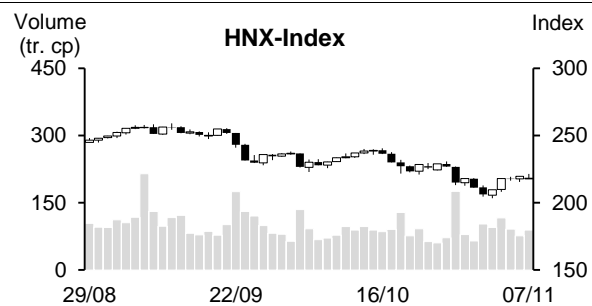
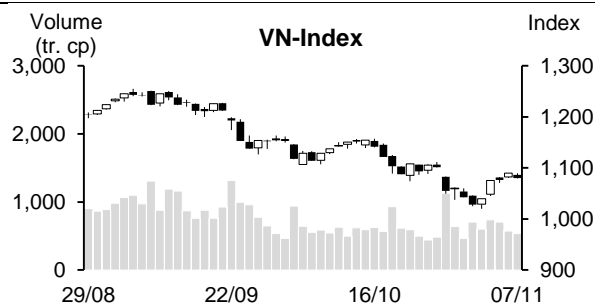

### REMARKABLE POINTS ON THE MARKET

The market corrected again as investors sold after previous gains. VN-Index was in red in most trading time with much more droppers, focusing mainly on real estate, securities, food and beverage, and banking. However, dropping range wasn't strong, and the liquidity was lower than recent sessions, showing that sellers weren't too determining. On the other side, there were still some positive gainers with better volume today, especially CTD, PVD, PVT, DCM, and PC1. After 5 net buying sessions in a row on both HOSE and HNX, foreign investors returned to net selling today.

### TECHNICAL POINT OF VIEW

In technical term, VN-Index dropped again. The volume dropped to below 10 and 20-session average, showing cautious cash flow. Not just that, the index still saw pressure from MA20 that dropped, and +DI was below -DI, showing that the main trend is still dropping. Moreover, the index also approached MA20 and dropped again, and RSI tended to weaken, showing that this technical recovery is passing and the index might see correcting pressure again toward old bottom around 1,020 points. For HNX, HNX-Index saw similar situation. It also dropped and still saw pressure from MA20 that dropped, and +DI was below -DI, showing that correcting pressure is returning and the index might soon return to sentimental support of 200 points. In general, the market showed weakening sign after the drop on November 7. Therefore, investors should limit opening new high-price chasing buying and consider selling T+ surfs, to limit unexpected risks from general market.

**DAILY NEWS****Domestic news****Nearly 400,000 domestic stock accounts suddenly closing in October**

According to Vietnam Stock Depository (VSD), total domestic accounts at the end of October is only over 7.4 million, which is 377,973 accounts less than the end of September.

Number of stock accounts dropped mainly from individuals. In October, number of domestic stock accounts dropped by 378,137 units to 7.38 million accounts (or 7.4% population). On the contrary, domestic institutes opened 164 new accounts, bringing total account to 15,885.

Different from the drop from domestic investors, foreign investors opened 246 new accounts in October, slightly lower than 253 accounts in previous month. For structure, individual investors opened 229 new accounts, institutes opened 17 accounts last month. At the end of October, total foreign account is 44,952.

**After many days standing still, deposit interest rate dropped in banks**

From November 1 – 4, no more banks adjusting mobilizing interest rate after Sacombank. This is the first time in 6 months that deposit interest rate sees no adjustment in 2 working days in a row.

Two banks lowered interest rate in November are VIB and VPBank. Accordingly, VIB announced new interest rate that dropped further in many terms. In detail, online rate for 1-3-month terms is 3.8%/year; 3-5-month also dropped to 4%/year; 6-8-month is 5.1%/year; and 15-18-month dropped to 5.6%/year.

VPBank also lowered mobilizing interest rate in below-6-month terms. Online rate for 1-2-month dropped by 0.2 percent-points to 3.7%/year; 3-5-month by 0.15 percent-points to 3.8%/year.

Online mobilizing rate in other terms stayed the same in VPBank. 6-11-month rate is 5%/year; 12-13-month is 5.3%/year, while 15-36-month rate is 5.1%/year.

From the beginning of November until now, there are three banks lowering mobilizing interest rate: Sacombank, VIB, and VPBank.

**Over 41 trillion dong of company bonds maturing in the last two months**

According to Vietnam Bond Market Association (VBMA), total individual company bond issuing value in October 2023 is 20.8 trillion, buying 13.6 trillion. As of October 31, 2023, there are 18 individual company bond issuances in October, total value is 20.8 trillion. Average interest rate is 8.9%/year, average term is 3.6 years.

From the beginning of 2023 until now, total issuing value is over 209 trillion, including 25 public issuances at 23.8 trillion (accounting 11.4% total issuing value) and 171 individual issuances at over 185 trillion (accounting 88.6% total value).

In which, accounting the most is banking with over 99 trillion (47.3% total value).

In the last two months, there will be about over 41 trillion dong of bonds matured. Meanwhile, there are 16 bond lots delaying interest and original with total value of about over 1 trillion and 47 codes extended or changing interest rate.

## Listing Company News

### **VJC: Vietjet will soon offer 24.5 million shares to 3 institutes, mobilizing 2,450 billion**

On November 3, BoM of Vietjet Airlines (HOSE: VJC) approved individual share offer. Accordingly, Vietjet will offer 24.5 million shares at most at the rate of 100,000 dong/share. Offering rate is 4.5% outstanding shares. Expected total offering value is 2,450 billion. Vietjet will offer these shares in Q4/2023.

List of VJC buyers in this issuance includes Leadvisor Fund Management (13.5 million shares), Amber fund Management (7.2 million shares), and Thanh Cong Fund Management (3.8 million shares). These institutes haven't held any VJC share.

### **ACB: bad debt increased strongly to 7 times of profit**

In 9 months, many banks released Q3/2023 finance statements with many indicators dropping. Asia bank (ACB) is a rare light with positive profit growth to above 10 trillion.

But total debt in ACB is 581,684 billion (customers' deposit is 445,499 billion), while equity capital is 66,825 billion, so debt is 8.7 times of capital.

According to Q3/2023 combined report, interest and similar income is 13,024 billion, up by 2,704 billion or 26.2% comparing to Q2/2022; in 9 months, the growth is 11,039 billion or 38.3% yoY. Q3/2023 EAT in ACB increased by 451 billion or 12.6% to 4,038 billion; in 9 months, it is 12,038 billion, up by 1,220 billion or 11.3% YoY.

Credit risk provision expense in 9 months in ACB increased by 724%. The reason is bad debt increasing strongly.

On September 30, 2023, total bad debt is nearly 5.4 trillion, up by 2,356 billion or 77.4% comparing to the end of 2022, accounting 1.21% total credit balance. Bad debt rate increased by 63.5%.

So, bad debt saw the strongest growth to 7 times of EAT.

### **PLC lowered 2023 EAT target by 30%**

Petrolimex Chemical (HNX: PLC) released written consulting on adjusting 2023 targets. Comparing to old target, PLC lowered selling revenue by 6% to 8,396 billion although the production is still the same. Accordingly, EAT dropped by 30% to 112 billion. So, comparing to new targets, revenue and EAT expect to drop by 2% and 20% comparing to 2022 results.

In 9 months, PLC net revenue is 5,774 billion and EAT is over 81 billion, down by 4% and 26% YoY. Comparing to adjusted targets, the company completed 69% revenue and 72% profit year-targets.

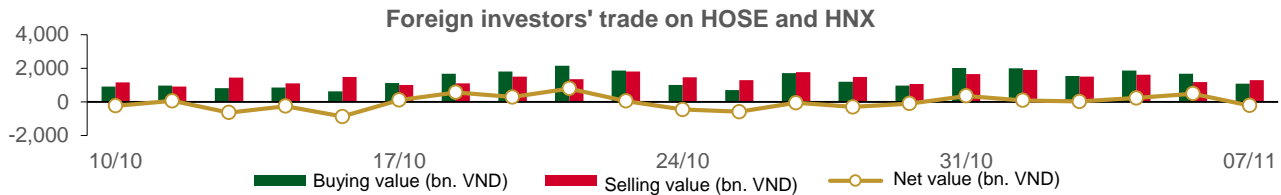

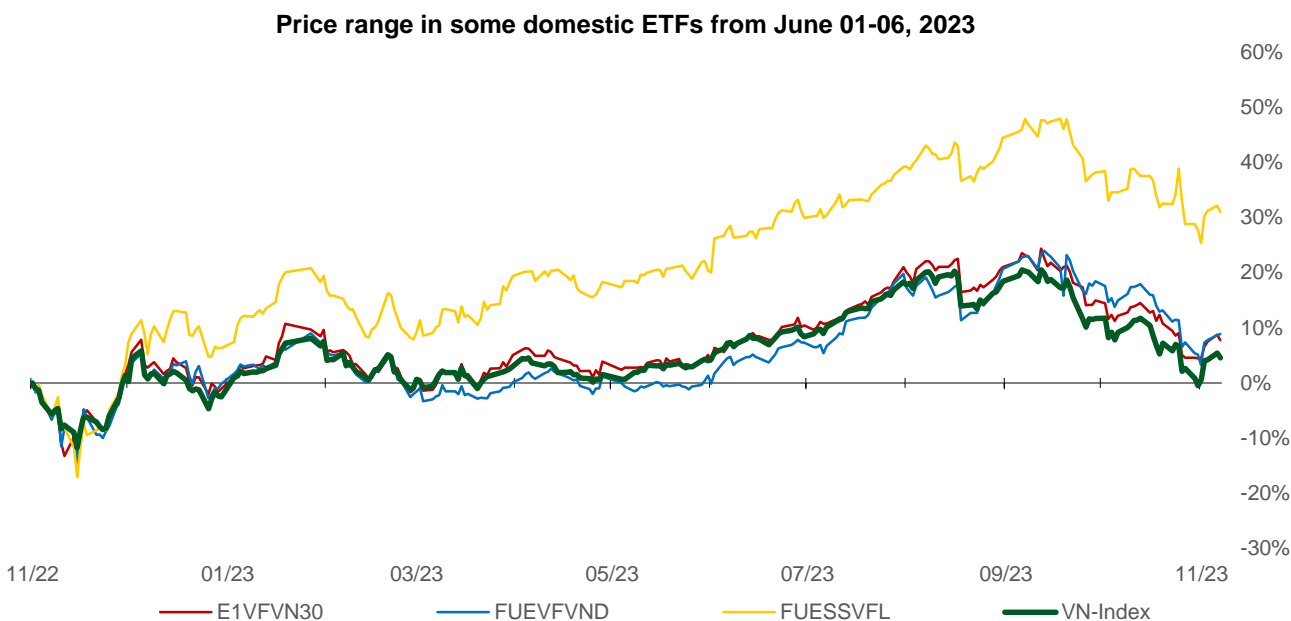
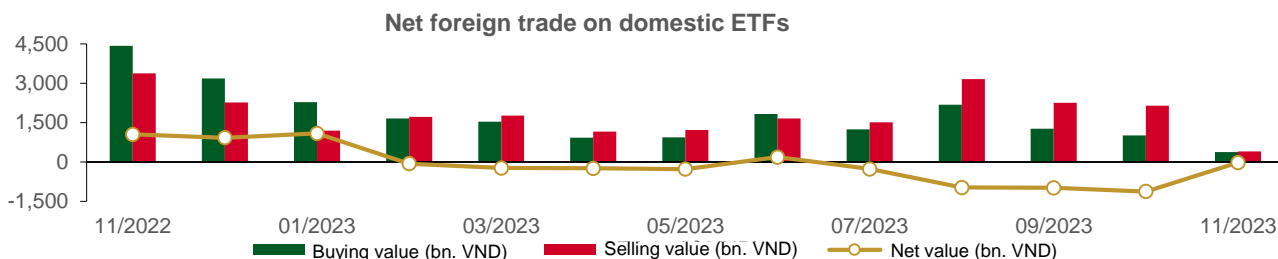
