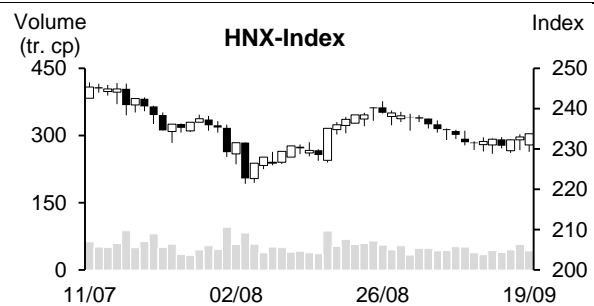
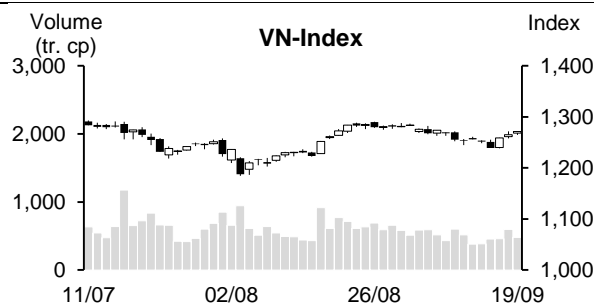

REMARKABLE POINTS ON THE MARKET

The market gained further during September derivative maturing session. Information of Fed lowering interest rate strongly last night and the approval of “pre-funding” helped improving the market’s confident. VN-Index stayed in green during the session before closing at day-highest level. Banking and real estate led the green while many other groups supported. On the other side, there was no group seeing negative drop. The liquidity dropped but was still at average as investors were cautious on derivative maturing day. Today is still a positive net buying session for foreign investors. This showed that foreign investors tended to return to Vietnam.

TECHNICAL POINT OF VIEW

In technical term, VN-Index saw another gain. There was sign of a dropping candle after yesterday head-withdraw one, and there was a small gaining candle with low volume, closing at day-highest level, showing that it might gain further to supply level of 1,275-1,290. For HNX-Index, it also gained. It corrected at the beginning and recovered again so there was a long gaining candle, there isn’t any difference and it is expected to be on gaining trend toward 237-242. General strategy might join in at average weight, having priority on groups like Retail, Real estate, Securities, Banking, Technology, Fertilizer, and Rubber.

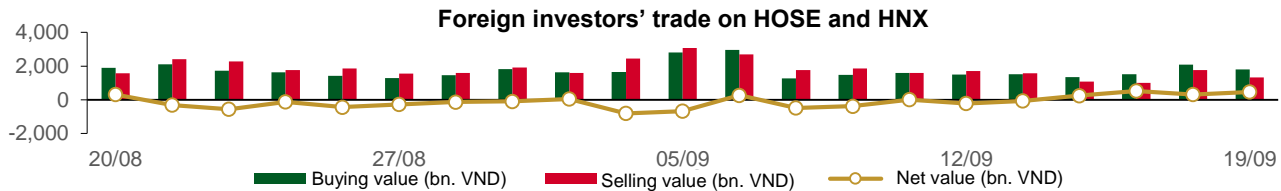

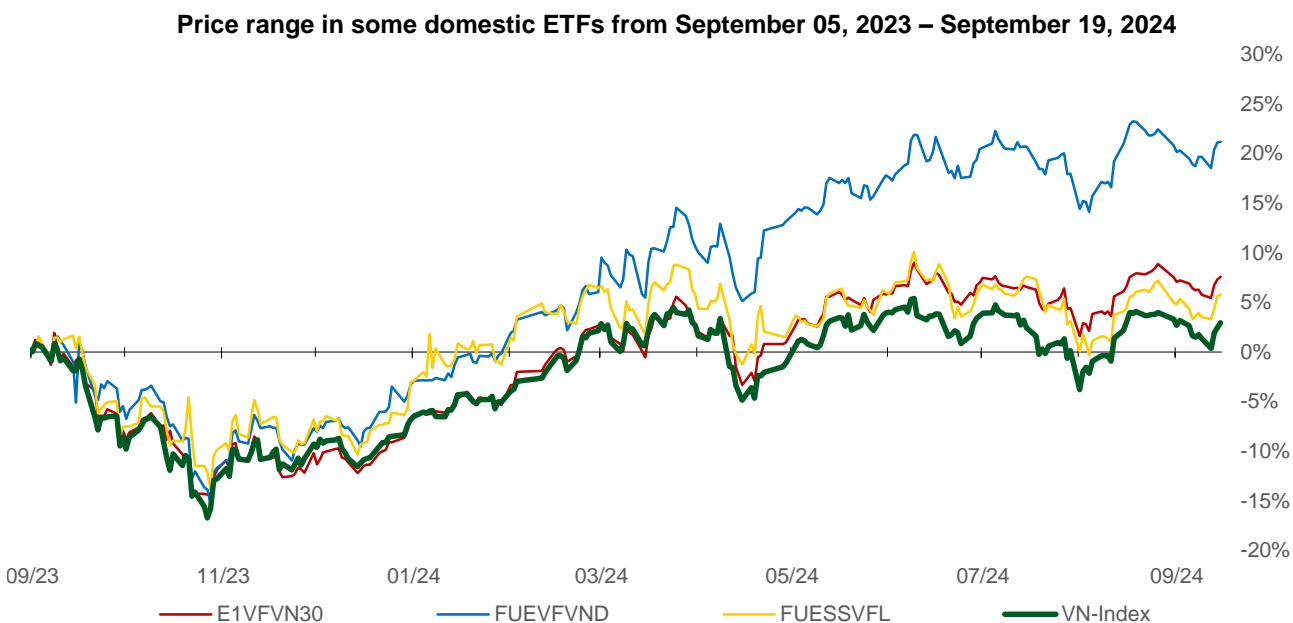
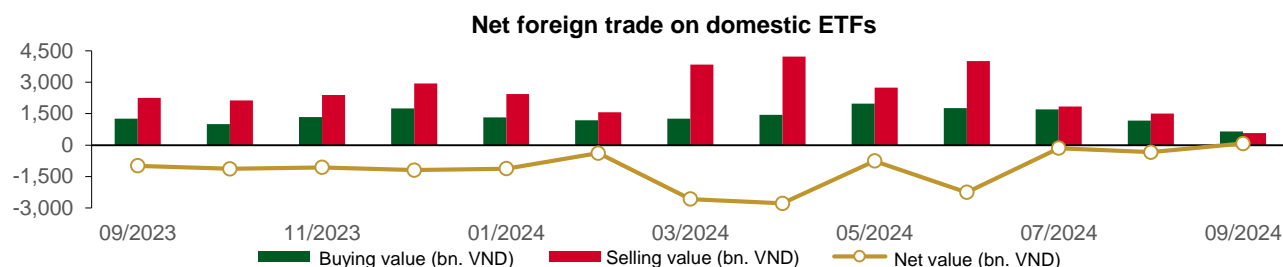
